

# PRIVACY DECLARATION

Cedo Nulli - Last changes: May 2018

This is the privacy declaration of Cedo Nulli (Burgemeester Oudlaan 50, Erasmus University Rotterdam), registered in the commercial register of the Chamber of Commerce with registration number 40343328.



You share your personal details with us: either conscious or not. We think it's important that we handle your personal details with care. Therefore, in this document we explain how we process your data and what rights you have. Do you have questions after reading this statement, please send an email to secretary@cedonulli.nl.

# 1. Use of personal data

- 1.1 We ask for your personal data when:
  - (a) you become a member of Cedo Nulli by registration via:
    - a. the Cedo Nulli website
    - b. a registration form
  - (a) you sign up for an activity or trip via:
    - a. the Cedo Nulli website
    - b. a registration form
    - c. a Google Form
- 1.2 In that way, we collect the personal data below:
  - (a) name + surname;
  - (b) address + zip code;
  - (c) e-mail address;
  - (d) telephone number;
  - (e) student number;
  - (f) birth date;
  - (g) bank account number (IBAN);
  - (h) study + study phase;
  - (i) BSN number (for some activities).
- 1.3 We only ask for your personal data when we have a reason to do so. We use this data (possibly):
  - (a) name: to identify you as a member
  - (b) address: for invitations by post or formal correspondence
  - (c) e-mail address: to send newsletters and:
  - (d) to send mailings
  - (e) telephone number: to call you in reference to applications at Cedo Nulli or when you don't show up at an activity you signed up for without specification
  - (f) birth date: to identify whether alcohol use is allowed during Cedo Nulli events such as study trips, drinks and parties
  - (g) bank account number: to collect the yearly membership fee

(h) study + phase: to bring events to the attention of students of a specific study or study phase



 BSN number: for booking flight tickets and hostels if necessary and for some specific activities where a BSN number is required (for example prison visit)

# 2 Retention period

- 2.1 Personal data are stored for a certain period of time, dependent on the reason they are asked. After this period, all data will be removed:
  - (a) registration at Cedo Nulli: during membership period and two years after, financial administration for 7 years as legally obliged.
  - (b) registration for activities/parties: until the activity or trip has taken place, unless a coherent activity takes place later (for example an after drink or evaluation). In that case, this will be communicated in time.

### 3 Photos and videos

3.1 During events, photos or videos could be taken. This footage is only used for promotion canals (such as Facebook and Instagram) and the Cedo Nulli website. When you wish that certain pictures or videos were removed, this will happen immediately. When you wish not to be photographed or filmed, you can contact the board prior to the activity (secretary@cedonulli.nl).

# 4 Information, correction and protest

  - (a) want more information about the way we process your personal data;
  - (b) have questions following this privacy policy;
  - (c) want to request inspection, correction or removal of your personal data;
  - (d) have protest or complaints about the use of your personal data.

## 5 Third parties

- 5.1 We provide your personal data to the following third parties:
  - (a) Partners of Cedo Nulli

The only personal data we share with partners are your name, study phase and e-mail address. However, they will receive this information only in an indirect way, for example because we send vacancies in the name of a company. This means your personal data will not be shared directly with a third party.

For some career related activities, you will have to send your CV. Your CV might be shared with the company that is organizing the activity. When this is the case, you will be informed about this timely.

### 6 Notification to person involved

6.1 When a breach of security takes place, you will be notified when the breach has possible consequences for your personal life.



#### 7 Cookies

7.1 A cookie is a small text file which is sent along with the pages of a website and Is saved by the browser on your computer, tablet or mobile phone. We use cookies to offer you a better service while visiting our website. For example, cookies make sure you stay logged in at a website or that your preferences, such as location and language settings are remembered. Due to cookies we can find out how often our website and which pages – are visited.

To place certain cookies you need to give permission before these cookies may be used. This permission is not necessary when it contains technical necessary (functional) cookies and analytical cookies, as Article 11.7a, Clause 3 states (Telecommunicatie en de ePrivacy Verordening).

You can always withdraw your permission by changing your Internet settings. More information about turning on and off and removing cookies can be found in the Help function of your browser.

### 8 Changing of the privacy policy and contact details

- 8.1 The association adjusts the privacy policy to keep it up-to-date. On the website you can find the most recent version of our privacy declaration. The association advises you to regularly check the current declaration. When important changes are made, the association will inform you by e-mail and via the website.
